Enrolment Procedure

All families that make an enquiry are provided with information regarding the school and invited to attend a tour. **All families must attend a tour as part of the enrolment procedure.** Tours afford an opportunity to see the school in action and ask any questions that you may have.

After completing this form and lodging it with a non-refundable application fee of \$180, an interview will be arranged at a mutually convenient time for you and your child. The interview is important for you, your child and Glenaeon. It is an opportunity for us to meet, discuss both the school and the particular class culture, operations and expectations. It is a further opportunity for you to ask any questions you may have.

The information you provide on this form is confidential and will be carefully recorded and used in future to maintain contact with you.

Glenaeon is non-selective however we do administer a pre-entry assessment to judge your child's skills in comparison with the class s/he is applying to enter. We also require copies your child's last two school reports and any other recent assessments, including those related to special needs. Glenaeon has a practice of providing an equal number of places for boys and girls and wherever possible attempts to ensure gender balance in each class. Glenaeon is open to all students regardless of cultural, socio-economic or religious background.

Priority is given to children currently attending Glenaeon Rudolf Steiner Preschool, siblings of students already enrolled at Glenaeon, the children of ex-students and to those currently attending other Steiner Waldorf schools. All students are expected to demonstrate a willingness and ability to support Glenaeon's ethos and to apply themselves academically and participate fully in school life. Parents, guardians and partners of same are also expected to become involved in the community life of the school and commit to understand the Steiner Waldorf educational philosophy.

All enrolment procedures and practices comply with the various state and federal anti-discrimination laws.

In assessing applications for enrolment, each prospective student's educational needs are considered and where necessary, further information is sought in consultation with parents/guardians and other relevant parties.

Date of application, gender, sibling status, readiness for school, academic progress and co-curricular involvement are all factors (as appropriate) that are taken into account.

After receiving a Letter of Offer for a place in Glenaeon, you may secure the place for your child by returning the Acceptance of Placement form, together with the non-refundable Enrolment Fee.

The amount to be paid and due date will be indicated in the Letter of Offer.

The Acceptance of Placement becomes a legally binding contract between you and Glenaeon.
