## ENROLMENT PROCEDURE

All families making an enquiry are provided with information regarding the school and invited to attend a tour. **All families must attend a tour as part of the enrolment procedure.** Tours afford an opportunity to see the school in action and ask any questions that you may have.

After completing this form and lodging it with a non-refundable application fee of \$385 you will be included on the Class Waiting List. When a place becomes available in the class, an interview will be arranged at a mutually convenient time for you and your child. This interview is important for you, your child and Glenaeon and provides an opportunity for us to meet, discuss the school and the particular class culture, operations and expectations. It is a further opportunity for you to ask any questions you may have.

If a place is offered to your child, an Enrolment Fee of \$2,250 must be paid and the Acceptance of Offer and Enrolment Forms need to be signed and returned by the date specified in the Letter of Offer. If a place is not offered, you will be notified by mail.

The information you provide on this form is confidential and will be carefully recorded and used in future to maintain contact with you. It is important that we are informed of any academic or behavioural issues including any special needs the student has, including medical or mental health issues, physical or intellectual conditions or disabilities. Please attach any relevant documentation, such as reports from health professionals or other consultants. If this section is left blank we will assume the student has no special needs. Failure to provide this information accurately and fully may delay the enrolment process or prevent an offer of a place being made.

Glenaeon is non-selective, however we do administer a pre-entry assessment to judge your child's skills in comparison with the class s/he is applying to enter. We also require copies of your child's last two school reports and any other recent assessments, including those related to special needs. Glenaeon has a practice of providing an equal number of places for boys and girls and wherever possible attempts to ensure gender balance in each class. Glenaeon is open to all students regardless of cultural, socio-economic or religious background.

Priority is given to children currently attending Glenaeon Rudolf Steiner Preschool, siblings of students already enrolled at Glenaeon, the children of Alumni and to those currently attending other Steiner Waldorf schools. All students are expected to demonstrate a willingness and ability to support the ethos of Glenaeon, to apply themselves academically and participate fully in school life. Parents and guardians are also expected to become involved in the community life of the school and commit to understand the Steiner Waldorf educational philosophy.

All enrolment procedures and practices comply with the various state and federal anti-discrimination laws.

In assessing applications for enrolment, each prospective student's educational needs are considered and where necessary, further information is sought in consultation with parents/guardians and other relevant parties.

Date of application, gender, sibling status, readiness for school, academic progress and co-curricular involvement are all factors (as appropriate) that are taken into account as are the needs of the children already enrolled in a particular class.

## TERMS AND CONDITIONS

1. A separate Application Form must be completed for each child seeking entry.
2. Places are offered to prospective students only after an interview by school officers.
3. Fees are due and payable on the first day of each term.  
Accounts will be sent by email beforehand.
4. A non-refundable Enrolment Fee of \$2,250 is payable upon acceptance and before a student commences at Glenaeon Rudolf Steiner School.
5. One full term's written notice of the withdrawal of a student from the school is required, otherwise the term's fees will be charged in lieu of notice.
